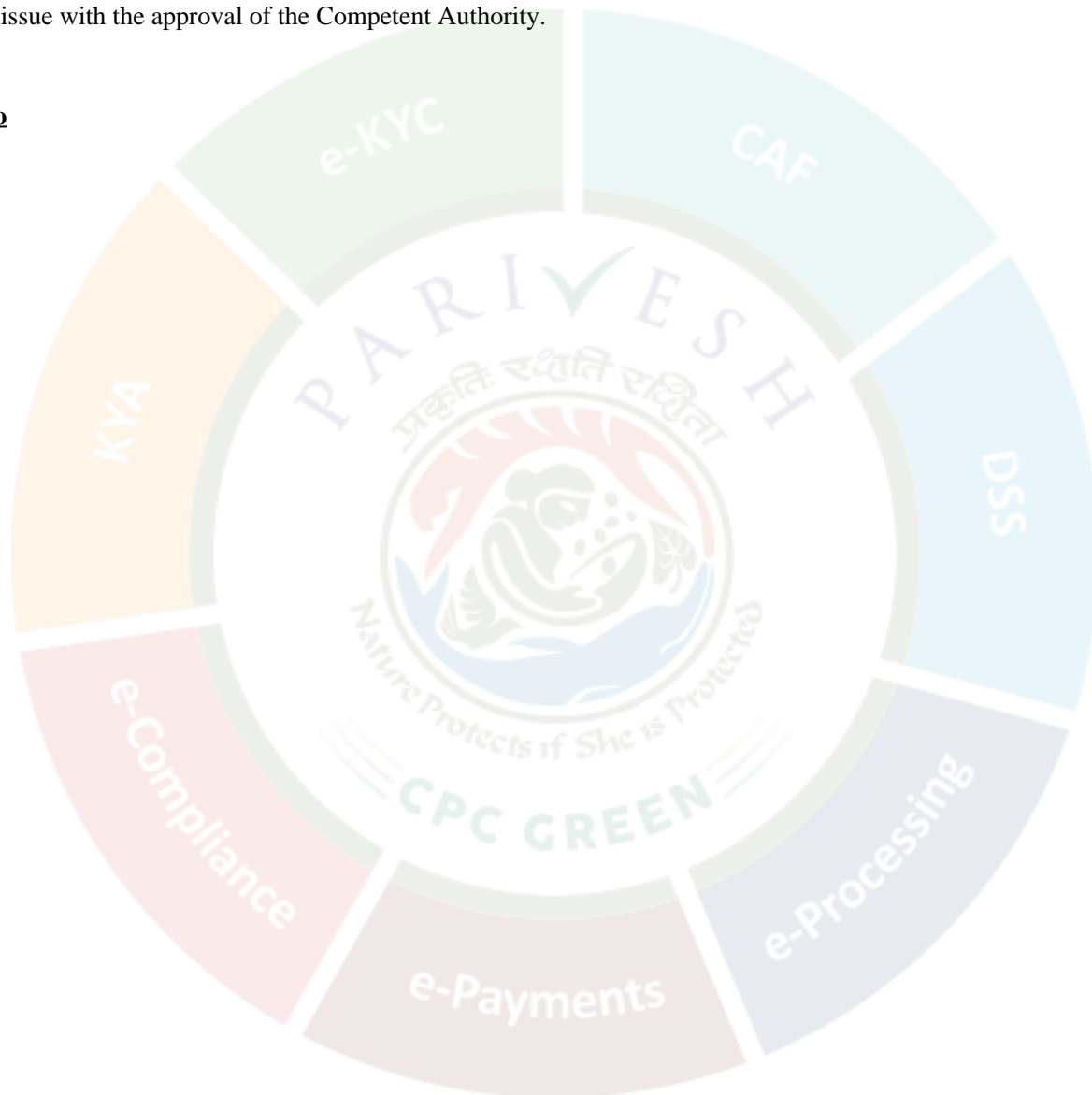

also agreed for the transfer on the same terms and conditions under which prior Environmental Clearance was granted. Deputy Commissioner, Sahibganj has also transferred the lease deed vide GRN Number : 2504046445 , dated : 23.08.2025 in the favour of "M/s Aditya Enterprises (Proprietor : Shri Chintu Kumar Bhagat)". District Mining Officer, Sahibganj vide memo no. 1607/M, dated 30.08.2025 certified that said project falls under grid no. 2 and production is within the over all permissible production limit. The DMO also stated that this certificate is issued in the light of order passed by Hon'ble NGT on 22.12.2021 in OA No. 23/2017/EZ, O.A. no. 776/2018 and O.A. no. 373/2019. It also states this certificate is issued in compliance of report of Expert Committee)".

3. The proposal was considered by the State Level Environment Impact Assessment Authority, Jharkhand in its 126th meeting held on 24th & 25th September, 2025 and the Authority has approved the proposal for transfer of Environmental Clearance in the name of "M/s Aditya Enterprises (Proprietor : Shri Chintu Kumar Bhagat)".

4. The Authority has no objection for transfer of Environmental Clearance accorded by the SEIAA, Jharkhand letter no. : EC/SEIAA/2018-19/2232/2019/685, dated : 08.11.2019 in the name of "M/s Aditya Enterprises (Proprietor : Shri Chintu Kumar Bhagat)" from "M/s Shiv Shakti Enterprises (Proprietor : Shri Abhishek Prasad)" with the same terms and conditions under which prior Environmental Clearance was granted for the same validity period subject to satisfactory compliance of all the stipulated specific and other conditions.
