उपर्युक्त प्रासंगिक विषयक सूचित करना है कि प्रश्नगत परियोजना की
पर्यावरणीय स्वीकृति तत्कालीन SEAC, झारखण्ड की 108वीं बैठक दिनांक 19 से
25.09.2023 के अनुशंसा के आलोक में तत्कालीन SEIAA, झारखण्ड की 109वीं बैठक
दिनांक 27 एवं 28.09.2023 के निर्णय के आधार पर इस कार्यालय के पत्रांक
EC/SEIAA/2023-24/2936/2023/286 दिनांक 06.10.2023 द्वारा निर्गत की गई थी।

उक्त वर्णित पर्यावरणीय स्वीकृति प्राप्त करने हेतु आपके द्वारा बी-2
श्रेणी अंतर्गत दिनांक 09.09.2023 को ऑनलाईन आवेदन (Proposal no. :
SIA/JH/MIN/443746/2023) किया गया था, जिसमें सभी सुसंगत अभिलेखों के साथ
जिला खनन पदाधिकारी, पाकुड़ द्वारा निर्गत Cluster प्रमाण-पत्र (ज्ञापांक 1693, दिनांक
22.07.2023) समर्पित किया गया था, जिसमें प्रतिवेदित है कि आवेदित क्षेत्र के 500
मीटर के अंदर कोई खनन पट्टा धारित नहीं है तथा कुल रकवा 5.83 एकड़ (2.35
हे०) है (छायाप्रति संलग्न)।

उल्लेख्य है कि आपके द्वारा पुनः प्रश्नगत मामले में पर्यावरणीय स्वीकृति प्राप्त करने हेतु **बी-1 श्रेणी** अंतर्गत आवेदन (Proposal no. : SIA/JH/MIN/502018 /2024) दिनांक 20.10.2024 को ऑनलाईन किया गया है, जिसे SEAC के 118वीं बैठक दिनांक 22 से 26.10.2024 में आकलन हेतु रखा गया तथा आकलन के क्रम में यह पाया गया कि आपके द्वारा पूर्व में SEIAA/SEAC से **बी-2 श्रेणी** अंतर्गत पर्यावरणीय स्वीकृति पत्रांक EC/SEIAA/2023-24/2936/2023/286 दिनांक 06.10.2023 प्राप्त किया गया है, जिसके लिए आपके द्वारा श्रेणी **बी-2** अंतर्गत ऑनलाईन प्रस्ताव (Proposal no. : SIA/JH/MIN/443746/2023) दिनांक 09.09.2023 को समर्पित किया गया था। SEAC द्वारा आकलन के क्रम यह भी प्रकाश में आया कि आपके द्वारा समर्पित जिला खनन पदाधिकारी, पाकुड़ के प्रमाण –पत्र ज्ञापांक 1693, दिनांक 22.07.2023 में छेड़-छाड़ करते हुए **बी-2 श्रेणी** अंतर्गत पर्यावरणीय स्वीकृति प्राप्त की गई है। इस मामले में SEAC के 118वीं बैठक दिनांक 22 से 26.10.2024 में प्रेषित अनुशंसा (**छायाप्रति संलग्न**) को निम्नवत उद्धृत किया जा रहा है:—

“The project has been granted EC by DELAA, Pakur vide letter no. 167 DELAA dated 09.09.2017.

As per O.M. dated 28th April 2023 issued by MOEF & CC projects which have been granted EC by DELAA are to be reappraised by SEIAA / SEAC.

This is re-appraisal of the EC issued by DELAA, Pakur which has been taken up for consideration on 25.10.2024. As per O.M. dated 12.12.18 issued by MOEF & CC projects fall in category B1.

During appraisal it was found that the project authorities have already obtained EC from SEIAA, Jharkhand vide letter no. EC/SEIAA 2023-24/2936 2023 286, dated 06.10.2023 under B2 category based on cluster certificate issued by DMO, Pakur vide memo no. 1693/M, dated 22.07.2023 stating that no other mine lease exists in the cluster. Hence area of the cluster stated as 5.83 acres (2.35 Ha) which is the same area of this project.

Now the project authorities have made a fresh application bearing proposal no. SIA/JH/MIN /502018/2024 for consideration of the project under DELAA to SEIAA re-appraisal of EC. The current cluster certificate from DMO, Pakur vide memo no. 1398/M dated 02.09.2024 states that one more mine (lease period 26.02.2016 for a period of 10 years) exists within the cluster and hence the total cluster area specified as 17.60 acres (7.12 Ha.).

The project authorities have concealed the fact that they have already obtained EC from SEIAA vide letter no. EC/SEIAA/2023-24/2936 2023 286, dated 06.10.2023 under B2 category.

As per the present DMO certificate the other mine in the cluster is in existence since 26.02.2016. Hence, the credibility of the earlier DMO certificate issued vide memo no. 1693/M, dated 22.07.2023 is doubtful.

In view of the above the SEAC is of the opinion that the project authorities have made application to SEIAA / SEAC manipulating and concealing the actual facts.

Therefore, the Committee recommends revoking the earlier ECs issued to the project and initiate necessary action as applicable.”

तद्आलोक में SEIAA. झारखण्ड की 118वीं बैठक दिनांक 28 एवं 29.11.2024 में विचारोपरांत लिये गये निर्णय (**छायाप्रति संलग्न**) के आलोक में आपसे पृच्छा की जाती है कि इस कार्यालय द्वारा पूर्व में निर्गत पर्यावरणीय स्वीकृति पत्रांक EC/SEIAA/2023-24/2936/2023 /286 दिनांक 06.10.2023 को पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, भारत सरकार के अधिसूचना सं० 637 (अ), दिनांक 28.02.2014 द्वारा प्रदत्त शक्तियों के आलोक में **क्यों नहीं रद्द** किया जाय। साथ ही निर्धारित अवधि में किये गये अवैध खनन कार्य हेतु पर्यावरण (संरक्षण) अधिनियम, 1986 के तहत आपके विरुद्ध **क्यों नहीं** कार्रवाई की जाय।

अतः अनुरोध है कि पत्र प्राप्ति के 10 दिनों के अंदर अपना स्पष्टीकरण इस कार्यालय में समर्पित करने का कष्ट करें।

MINUTES OF THE 118TH MEETING OF STATE LEVEL EXPERT APPRAISAL COMMITTEE (SEAC), JHARKHAND HELD ON 22ND, 23RD, 24TH, 25TH AND 26TH OCTOBER, 2024.

The 118th meeting of State Level Expert Appraisal Committee (SEAC), Jharkhand was held on 22nd, 23rd, 24th, 25th and 26th October, 2024 under the Chairmanship of Shri Ashok Kumar Singh, IFS (Retd.) in the Conference Room at SEAC, Ranchi.

SEIAA forwarded various projects to the SEAC for the technical appraisal after the last SEAC meeting held on 27th, 28th, 29th, 30th September, 2024 and 01st October, 2024. These projects have been put up for discussions. Besides, these Projects, wherein PP's were asked to provide requisite information / clarifications in the earlier meeting of SEAC, were also considered for appraisal. The Project Proponents have been asked to make technical presentation for the appraisal of their projects before the committee.

The following observations / recommendations were made during the presentation (Project - wise), as under:-

Consideration of proposals

Name of the consultant : M/s Oceao-Enviro Management Solutions (India) Pvt. Ltd, Ghaziabad

This is an expansion project which has been taken for appraisal on 22.10.2024.

As per decision taken in 117th meeting of SEAC held from 27.09.2024 to 01.10.2024 site visit was carried out by the Committee for the understanding of the actual status of the project.

Project is classified as Category 8(a) as per EIA Notification as the built up area is less than 1,50,000 m² and development area is less than 50 ha.

The proposed project is construction of Expansion Of Residential Complex "Diamond City" of M/s Eastern Estate Construction and Developers Pvt. Ltd., Village: Oyana, District: Ranchi, Jharkhand. 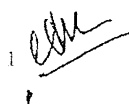
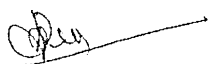

9. SEIAA considered the Recommendations of SEAC in its 118th meeting held on 22nd, 23rd, 24th, 25th and 26th October, 2024 for grant of Terms of Reference (ToR) to the following Coal Washery project:

1. Proposed Green Field Project to Set-up wet 2.48 MTPA Coal Washery by M/s Omkar Coal Washeries Pvt. Ltd., Village : Olhepat, Tehsil : Balumath, Distt.: Latehar, Jharkhand (7.48 Ha). (Proposal no.: SIA/JH/CMIN/500925/2024).

SEAC has appraised the above project and made unanimous recommendations for grant of ToR to above mentioned proposal. The SEIAA, based on the recommendation of SEAC, unanimously decided to grant ToR to the above mentioned project proposal with the conditions recommended by SEAC and alongwith the following specific conditions:

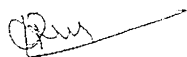
- i. In compliance of OM no.F.No. IA3-22/3/2024-IA.III (E-241594) dated 24.07.2024 of MoEF&CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign “*EK Ped Ma Ke Naam*” and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>).
- ii. Complete material balance including the media and flocculants to be provided.
- iii. Detailed water balance to be provided. Rain Water Harvested is also to be included.
- iv. Details of all the waste generation in the project along with handling and management of the same.
- v. Primary study to be carried out for Socio Economy, Ecology & Bio-Diversity, Geology and Hydro Geology.
- vi. Details of settling pond and cycle of concentration, if any.
- vii. Details of all the pollution control measures including ETP & STP, if any.
- viii. Details of fire control management plan.
- ix. Proposal for upgradation of health facilities to be provided to the nearest PHC is to be included in the EIA / EMP report.
- x. Management plan for the railway siding to be specifically detailed.
- xi. Undertaking for implementation of ZLD is to be incorporated in EIA report.

SEIAA examined the recommendation of SEAC in the light section 8(vi) of the EIA notification, 2006 and unanimously decided to authorize Member Secretary, SEIAA to issue a show cause to the project Authority for explaining his conduct in this matter and outcome of the case will again put up before SEIAA for final decision.

I. District Survey Report (Stone and Earth Work) of Ranchi district

After Technical presentation before SEAC and appraisal of DSR, the unanimous recommendation was sent to SEIAA for approval of District Survey Report for Minor Minerals other than Sand Mining or River Bed Mining (Stone and Earth Work) of Ranchi district, as the District Survey Report (Stone and Earth Work) contained all
