EC/SEIAA/2022-23/2674/2022/257, dated 01.09.2023.
- Your request has been examined by the State Level Expert Appraisal Committee (SEAC), Jharkhand in its 124th meeting held on 23rd, 24th, 25th, 26th and 27th June, 2025, based on the information furnished/provided and discussion held, the State Level Expert Appraisal Committee, (SEAC) recommended to issue corrigendum of earlier Environmental Clearance issued vide letter no.: EC/SEIAA/2022-23/2674/2022/257, Ranchi, Date: 01.09.2023 as the following:-

"The PA's vide online application no. SIA/JH/IND1/536606/2025 has requested for necessary correction in amendment EC issued vide letter no. EC/SEIAA/2024-25/3591/2024/73, dated 16.04.2025. The amendment EC issued had inadvertently mentioned the ToR letter number in place of the previous EC letter no. EC/SEIAA/2022-23/2674/2022/257, dated 01.09.2023.

The SEAC considered the same and recommends for issuance of corrected EC as stated above. Other terms & conditions mentioned in the previous EC letter no. EC/SEIAA/2022-23/2674/2022/257, dated 01.09.2023 shall remain the same along with following specific condition:

- i. In compliance of OM no. F.No. IA3-22/3/2024-IA.III (E-241594) dated 24.07.2024 of MoEF&CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign "Ek Ped Ma Ke Naam" and the details of the same shall be uploaded in the MeriLiFE Portal (https://merilife.nic.in). 10% of the total green belt proposed shall be allocated under this clause".
- 3. The recommendation of SEAC, Jharkhand in this regard has been examined by the State Level Environment Impact Assessment Authority, Jharkhand in its 124th meeting held on 15th & 16th July, 2025 and decided corrigendum in Environmental Clearance as recommended by SEAC above alongwith all other terms and conditions of earlier EC letter no. EC/SEIAA/2022-23/2674/2022/257, Ranchi, Date: 01.09.2023 and Amendment EC issued vide letter no. EC/SEIAA/2024-25/3591/2024/73, dated 16.04.2025 shall remain the same.
 - 4. This is issued with the approval of SEIAA, Jharkhand.


