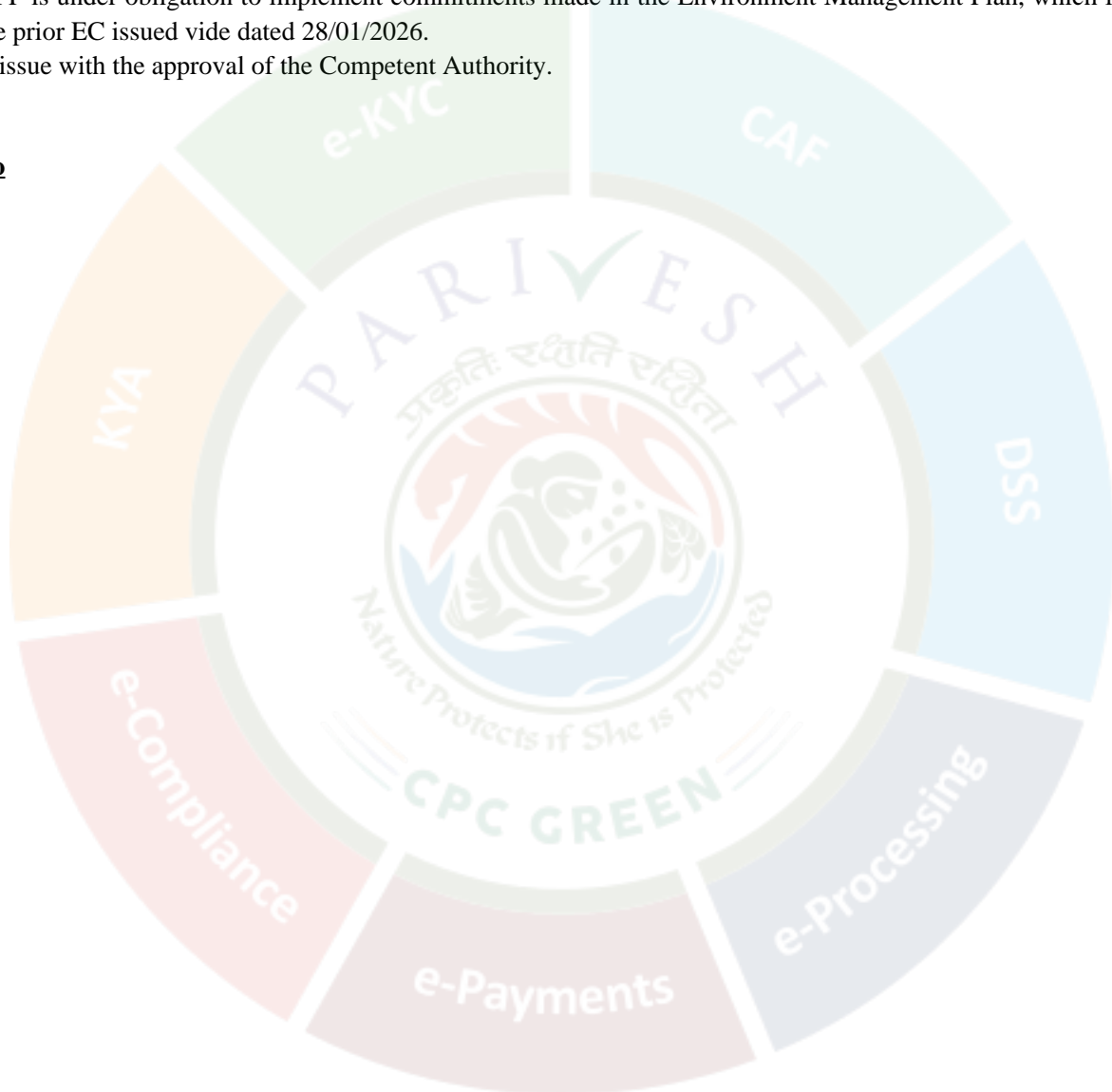

Kindly refer to online application no. : SIA/JH/MIN/567079/2026, wherein you have requested for transfer of Environmental Clearance issued by SEIAA vide letter No. EC/SEIAA/2024-25/3112/2024/71, dated : 24.05.2024 in the name of “Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawagi and Shri Amiya Goswami)” from “Asanchua Sand Ghat of M/s Jharkhand State Mineral Development Corporation Limited (JSMDC Ltd.)”.

2. Your request has been examined by the State Level Environment Impact Assessment Authority (SEIAA), Jharkhand in its 129th meeting held on 10th and 11th February, 2026, based on the information furnished/provided and discussion held, the State Level Environment Impact Assessment Authority (SEIAA) has decided to issue transfer of earlier Environmental

Clearance issued vide Letter no. : EC/SEIAA/2024-25/3112/2024/71, dated : 24.05.2024, as the following:

"The above mentioned project proposal was considered in the light of section 11 of Environment Impact Assessment Notification, 2006 for transferability of Environmental Clearance. The Environmental Clearance was granted by SEIAA, Jharkhand vide letter no. : EC/SEIAA/2024-25/3112/2024/71, dated : 24.05.2024 in the favor of " Asanchua Sand Ghat of M/s Jharkhand State Mineral Development Corporation Limited (JSMDC Ltd.), Village : Asanchua, Thana no. : 17, Thana : Jamtara, District : Jamtara, Jharkhand (1.27 Ha)." (Proposal No. : SIA/JH/MIN/472056/2024)".

The applicant vide online application no. SIA/JH/MIN/ 567079 /2026 has submitted that *Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)* has been selected successful bidders of "Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami) at Khata No. : 60, Plot No. : 1310 at Village : Asanchua, Thana no. : 17, Thana : Jamtara, District : Jamtara, Jharkhand (1.27 Ha)" under The Jharkhand Sand Mining Rules, 2025 and requested to transfer (transfer of ownership) of Environmental Clearance in favour of "*Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)*" for which he has submitted "No Objection Certificate" of M/s Jharkhand State Mineral Development Corporation Limited affirming that the Environmental Clearance will be transferred in favour of "*Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)*" and they do not have any objections regarding the transfer of Environmental Clearance and all the terms and conditions of Environmental Clearance dated 24.05.2024 shall be complied by "*Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)*" also undertaken that all the stipulated terms and conditions of EC letter no. : EC/SEIAA/2024-25/3112/2024/71, dated : 24.05.2024 shall be complied by him.

Jharkhand State Mineral Development Corporation Limited (JSMDC), Ranchi has also issued No Objection Certificate (NOC) vide Letter Number : 60, dated : 16.01.2026 in the favour of "*Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)*" and further informed that the said Sand Ghat has been transferred to "*Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)*" and LOI has been issued by District Mining Officer, Jamtara vide Letter No. : 687/M, Dated : 15.10.2025 in favour of "*Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)*".

The District Mining Officer, Jamtara issued a production certificate vide Letter No. : 62, Dated : 22.01.2026 stating that no mining operation has been carried in year 2024-25 and only production and dispatch of 60,200 cft sand has been done in year 2025-26 which is under permissible limit of Environmental Clearance.



The District Survey Report of Sand or River Bed Mining of **Jamtara** District has been prepared by Sub-Divisional Committee and submitted by Deputy Commissioner, **Jamtara** and same has been Appraised and Approved by SEIAA and SEAC, Jharkhand in the light of Environment & Monitoring Guidelines for Sand Mining 2020 / Hon'ble Apex Court order in Civil Appeal No. 3661-3662/2020, Pawan Kumar Vs State of Bihar & Hon'ble NGT Order in OA No. 54/2022/EZ, Bhumi Adhigrahan Visthapan Avam Punarvas Kisan Samiti Vs State of Jharkhand & Ors. This project is also a part of Approved District Survey Report.

The PAs has also undertaken through affidavit that Sand Mining will be commenced as per para 5.0 of Enforcement & Monitoring Guidelines for Sand Mining, 2020 regarding Replenishment study.

After the full deliberations, it was unanimously decided that Environmental Clearance issued vide letter no. : **EC/SEIAA/2024-25/3112/2024/71**, dated : **24.05.2024** is being transferred to "**Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)**" with the same terms and conditions under which prior Environmental Clearance was granted by SEIAA, Jharkhand for the same validity period subject to satisfactory compliance to all stipulated terms and conditions.

"Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)" is directed to obtain **Consent to Operate** from the State Pollution Control Board in the name of "**Asanchua Sand Ghat of M/s Asbolus Global Private Limited (Director : Shri Abhay Sarawgi and Shri Amiya Goswami)**" In case any change is proposed in the **Scope** of the project, the Project Authority (PAs) shall obtain fresh **Environmental Clearance**. The other specific condition of this transfer of Environment Clearance is as follows:-

- i. Deputy Commissioner, Jamtara through District Mining Officer, Jamtara will ensure that "**Replenishment study shall be conducted during pre-monsoon and post monsoon every year and study report have to be submitted to SEIAA / SEAC, Jharkhand. The production shall be restricted to 60% of the replenished quantity or the proposed quantity in the mine plan, which ever is less**" as per para 5.0 of Enforcement & Monitoring Guidelines for Sand Mining, 2020.
- ii. Deputy Commissioner, Jamtara shall ensure that lease will be executed only after obtaining all approvals applicable at the time of operation including compliance with the **Jharkhand Panchayats (Extension to Scheduled Areas) Rules, 2025 and Gram Sabha Consent**, wherever applicable".
