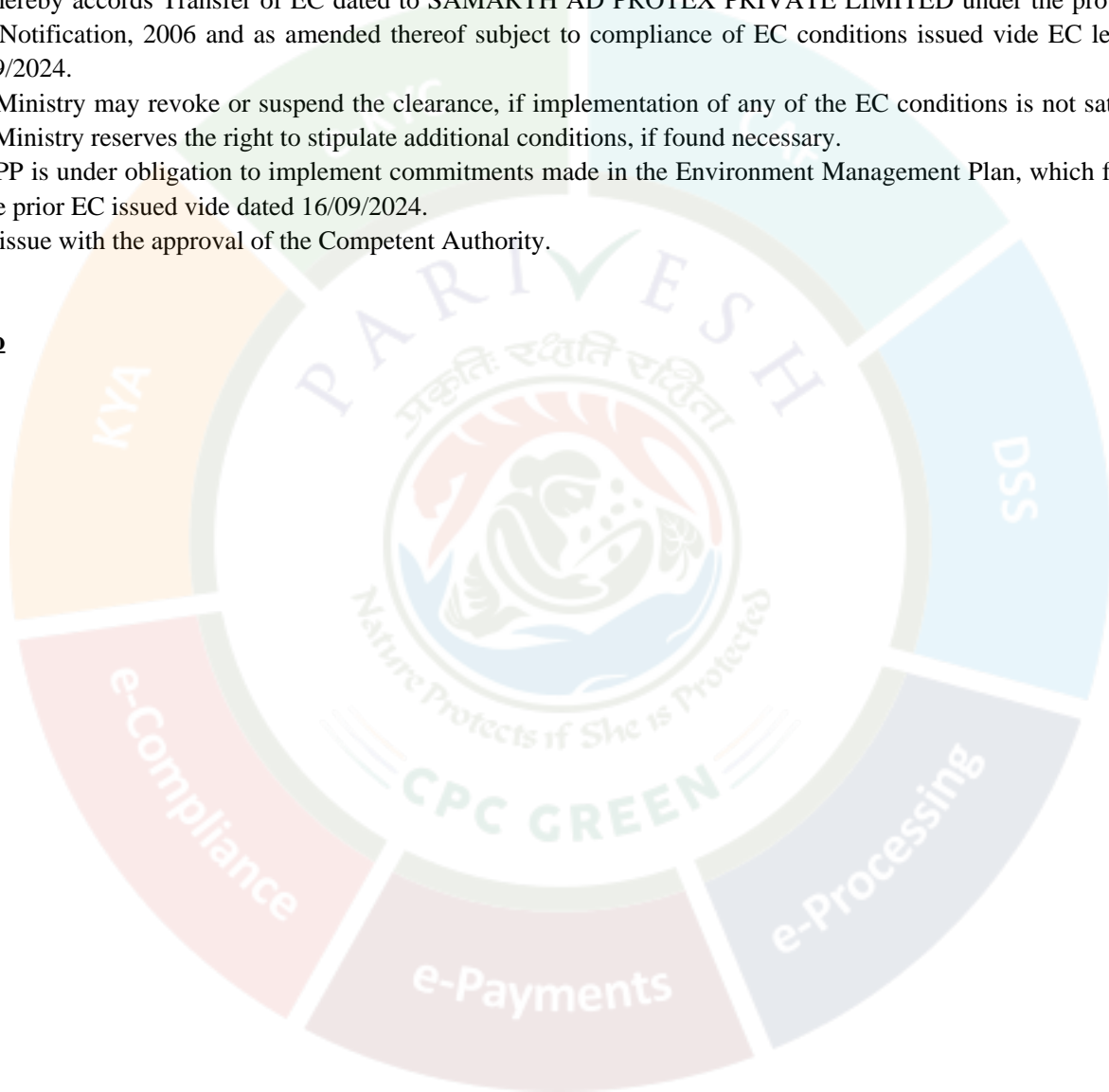

Kindly refer to online application no. : SIA/JH/MIN/567116/2026, wherein you have requested for transfer of Environmental Clearance issued by SEIAA vide letter No. EC/SEIAA/2024-25/3257/2024/292, dated : 18.10.2024 in the name of “Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)” from “Shyamnagar Sand Ghat (Subarnarekha River) of M/s Jharkhand State Mineral Development Corporation Limited (JSMDC Ltd.)”.

2. Your request has been examined by the State Level Environment Impact Assessment Authority (SEIAA), Jharkhand in its 129th meeting held on 10th and 11th February, 2026, based on the information furnished/provided and discussion held, the State Level Environment Impact Assessment Authority (SEIAA) has decided to issue transfer of earlier Environmental

Clearance issued vide Letter no. : EC/SEIAA/2024-25/3257/2024/292, dated : 18.10.2024, as the following:

"The above mentioned project proposal was considered in the light of section 11 of Environment Impact Assessment Notification, 2006 for transferability of Environmental Clearance. The Environmental Clearance was granted by SEIAA, Jharkhand vide letter no. : EC/SEIAA/2024-25/3257/2024/292, dated : 18.10.2024 in the favor of "Shyamnagar Sand Ghat (Subarnarekha River) of M/s Jharkhand State Mineral Development Corporation Limited (JSMDC Ltd.) at Village : Shyamnagar, Block : Silli, District : Ranchi, Jharkhand (5.00 Ha)" (Proposal No. : SIA/JH/MIN/496813/2024)".

The applicant vide online application no. SIA/JH/MIN/ 567116 /2026 has submitted that "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)*" has been selected successful bidders of "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)* at Khata No. : 27, Plot No. : 469 (P) at Village : Shyamnagar, Block : Silli, Distt. : Ranchi, Jharkhand (5.00 Ha)" under The Jharkhand Sand Mining Rules, 2025 and requested to transfer (transfer of ownership) of Environmental Clearance in favour of "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)*" for which he has submitted "No Objection Certificate" of M/s Jharkhand State Mineral Development Corporation Limited affirming that the Environmental Clearance will be transferred in favor of "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)*" and they do not have any objections regarding the transfer of Environmental Clearance and all the terms and conditions of Environmental Clearance dated 18.10.2024 shall be complied by "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)*" also undertaken that all the stipulated terms and conditions of EC letter no. : EC/SEIAA/2024-25/3257/2024/292, dated : 18.10.2024 shall be complied by him.

Jharkhand State Mineral Development Corporation Limited (JSMDC), Ranchi has also issued No Objection Certificate (NOC) vide Letter Number : 56, dated : 16.01.2026 in the favor of "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)* and further informed that the said Sand Ghat has been transferred to "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)*" and LOI has been issued by District Mining Officer, Ranchi vide Letter No. : 1290/M, Dated : 17.10.2025 in favor of "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)*".

The District Mining Officer, Ranchi issued a production certificate vide Memo No. : 141/M, Dated : 06.02.2026 stating that production and dispatch of 61100 cft sand has been done in year 2024-25 and production and dispatch of 438900 cft sand has been done in year 2025-26 which is under permissible limit of Environmental Clearance.

The District Survey Report of Sand or River Bed Mining of Ranchi District has been prepared by Sub-Divisional Committee and submitted by Deputy Commissioner, Ranchi and



same has been Appraised and Approved by SEIAA and SEAC, Jharkhand in the light of Environment & Monitoring Guidelines for Sand Mining 2020 / Hon'ble Apex Court order in Civil Appeal No. 3661-3662/2020, Pawan Kumar Vs State of Bihar & Hon'ble NGT Order in OA No. 54/2022/EZ, Bhumi Adhigrahan Visthapan Avam Punarvas Kisan Samiti Vs State of Jharkhand & Ors. This project is also a part of Approved District Survey Report.

The PAs has also undertaken through affidavit that Sand Mining will be commenced as per para 5.0 of Enforcement & Monitoring Guidelines for Sand Mining, 2020 regarding Replenishment study.

After the full deliberations, it was unanimously decided that Environmental Clearance issued vide letter no. : EC/SEIAA/2024-25/3257/2024/292, dated : 18.10.2024 is being transferred to "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)*" with the same terms and conditions under which prior Environmental Clearance was granted by SEIAA, Jharkhand for the same validity period subject to satisfactory compliance to all stipulated terms and conditions.

"Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)" is directed to obtain Consent to Operate from the State Pollution Control Board in the name of "*Shyamnagar Sand Ghat of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)*" In case any change is proposed in the Scope of the project, the Project Authority (PAs) shall obtain fresh Environmental Clearance. The other specific condition of this transfer of Environment Clearance is as follows:-

- i. Deputy Commissioner, Ranchi through District Mining Officer, Ranchi will ensure that "*Replenishment study shall be conducted during pre-monsoon and post monsoon every year and study report have to be submitted to SEIAA / SEAC, Jharkhand. The production shall be restricted to 60% of the replenished quantity or the proposed quantity in the mine plan, which ever is less*" as per para 5.0 of Enforcement & Monitoring Guidelines for Sand Mining, 2020.
- ii. Deputy Commissioner, Ranchi shall ensure that lease will be executed only after obtaining all approvals applicable at the time of operation including compliance with the **Jharkhand Panchayats (Extension to Scheduled Areas) Rules, 2025** and **Gram Sabha Consent**, wherever applicable".
