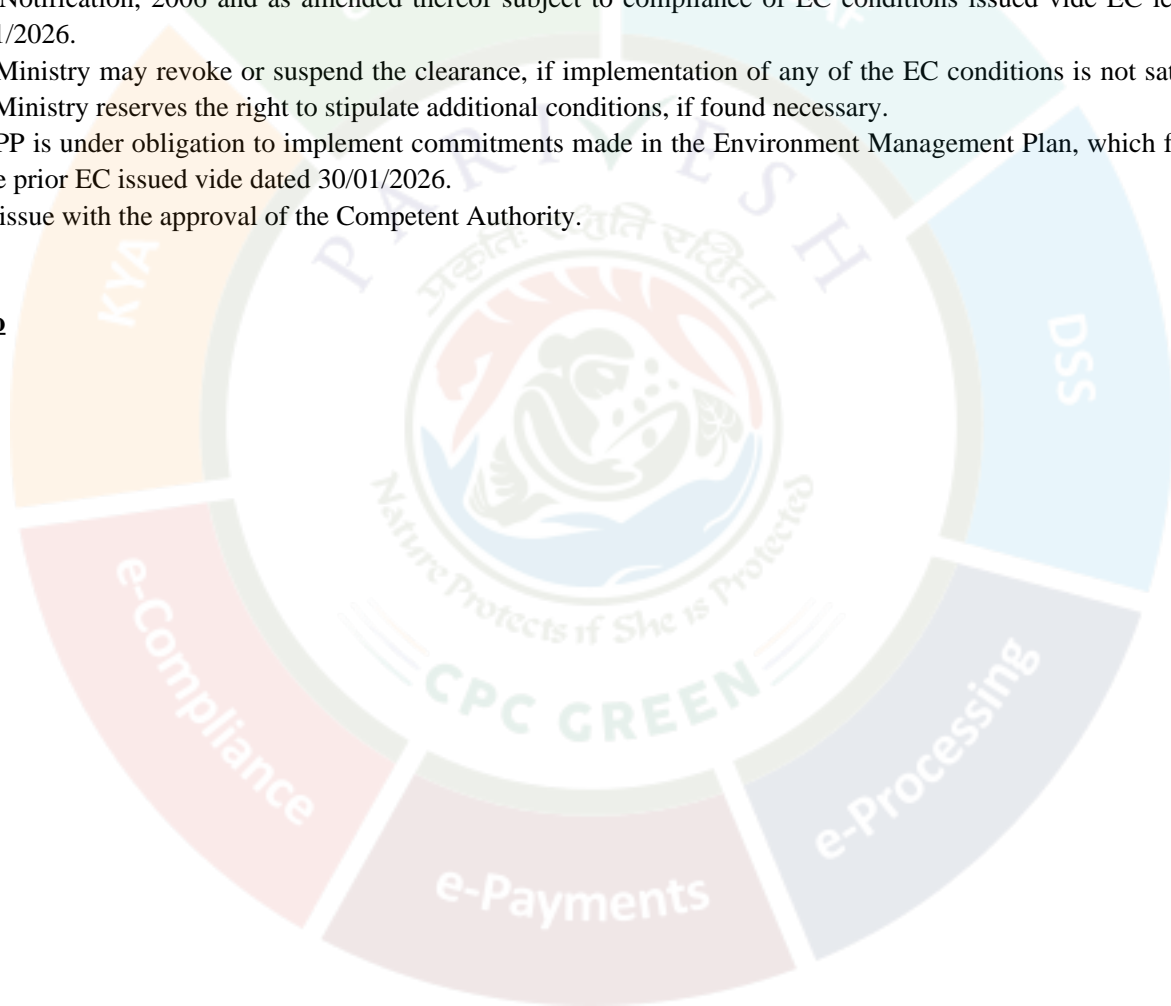

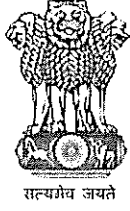

2. Your request has been examined by the State Level Environment Impact Assessment Authority (SEIAA), Jharkhand in its 129th meeting held on 10th and 11th February, 2026, based on the information furnished/provided and discussion held, the State Level Environment Impact Assessment Authority (SEIAA) has decided to issue transfer of earlier Environmental Clearance issued vide Letter no. : EC/SEIAA/2024-25/3161/2024/290, dated : 18.10.2024, as the following:

“The above mentioned project proposal was considered in the light of section 11 of Environment Impact Assessment Notification, 2006 for transferability of Environmental Clearance. The Environmental Clearance was granted by SEIAA, Jharkhand vide letter no. : EC/SEIAA/2024-25/3161/2024/290, dated : 18.10.2024 in the favor of "Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit Project on Barkagaon River Bed of M/s Jharkhand State Mineral Development Corporation Limited (JSMDCLtd.) at Village : Langatu, Sikri, Pandaria, Barkagaon & Sirma, Block : Barkagaon, District : Hazaribagh, Jharkhand (3.48 Ha)” (Proposal No. : SIA/JH/MIN/483029/2024)".

SIA/JH/MIN/ 567287 /2026 has submitted that “Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)” has been selected successful bidders of “Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal) at Plot No. : 2788, 2947, 3808, 1496, 183, 3982, 3683 & 01 at Village : Langatu, Sikri, Pandaria, Barkagaon & Sirma, Block : Barkagaon, District : Hazaribagh, Jharkhand (3.48 Ha)” under The Jharkhand Sand Mining Rules, 2025 and requested to transfer (transfer of ownership) of Environmental Clearance in favour of “Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)” for which he has submitted “No Objection Certificate” of M/s Jharkhand State Mineral Development Corporation Limited affirming that the Environmental Clearance will be transferred in favor of “Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)” and they do not have any objections regarding the transfer of Environmental Clearance and all the terms and conditions of Environmental Clearance dated 18.10.2024 shall be complied by “Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)” also undertaken that all the stipulated terms and conditions of EC letter no. : EC/SEIAA/2024-25/3161/2024/290, dated : 18.10.2024 shall be complied by him.

The District Mining Officer, Hazaribagh issued a production certificate vide Letter No. : 107/Khanan, Dated : 19.01.2026 stating that no mining operation has been commenced of proposed sand ghat till date.

The District Survey Report of Sand or River Bed Mining of Hazaribagh District has been prepared by Sub-Divisional Committee and submitted by Deputy Commissioner, Hazaribagh and same has been Appraised and Approved by SEIAA and SEAC, Jharkhand in the light of Environment & Monitoring Guidelines for Sand Mining 2020 / Hon'ble Apex Court order in Civil Appeal No. 3661-3662/2020, Pawan Kumar Vs State of Bihar & Hon'ble NGT Order in OA No. 54/2022/EZ, Bhumi Adhigrahan Visthapan Avam Punarvas Kisan Samiti Vs State of Jharkhand & Ors. This project is also a part of Approved District Survey Report.

The PAs has also undertaken through affidavit that Sand Mining will be commenced as per para 5.0 of Enforcement & Monitoring Guidelines for Sand Mining, 2020 regarding Replenishment study.

After the full deliberations, it was unanimously decided that Environmental Clearance issued vide letter no. : EC/SEIAA/2024-25/3161/2024/290, dated : 18.10.2024 is being transferred to *“Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)”* with the same terms and conditions under which prior Environmental Clearance was granted by SEIAA, Jharkhand for the same validity period subject to satisfactory compliance to all stipulated terms and conditions.

“Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)” is directed to obtain Consent to Operate from the State Pollution Control Board in the name of *“Langatu, Sikri, Pandaria, Barkagaon & Sirma Sand Deposit of M/s Samarth AD Protex Private Limited (Director : Shri Dhiraj Agarwal)”* In case any change is proposed in the Scope of the project, the Project Authority (PAs) shall obtain fresh Environmental Clearance. The other specific condition of this transfer of Environment Clearance is as follows:-

- i. Deputy Commissioner, Hazaribagh through District Mining Officer, Hazaribagh will ensure that *“Replenishment study shall be conducted during pre-monsoon and post monsoon every year and study report have to be submitted to SEIAA / SEAC, Jharkhand. The production shall be restricted to 60% of the replenished quantity or the proposed quantity in the mine plan, which ever is less”* as per para 5.0 of Enforcement & Monitoring Guidelines for Sand Mining, 2020.
- ii. Deputy Commissioner, Hazaribagh shall ensure that lease will be executed only after obtaining all approvals applicable at the time of operation including compliance with the Jharkhand Panchayats (Extension to Scheduled Areas) Rules, 2025 and Gram Sabha Consent, wherever applicable”.



3. In case any change is proposed in the scope of the project, the project Authority shall obtain fresh prior Environmental Clearance.

4. This letter has been issued with SEIAA, Approval.
