

Minutes of the 26th meeting of State level Environment Impact Assessment Authority, Jharkhand, held on 24th November, 2014.

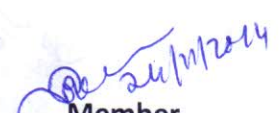

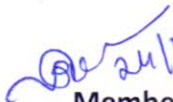

- ii. M/S Shah Sponge & Power Ltd at Village - Bhumri (Juri), Tehsil- Potka, District - East Singhbhum, Jharkhand.

Prescription number 31 in the ToR is deleted and replaced by the following –

Air pollution control measures from all point stationary sources during charging of raw materials and during operation of the furnaces, boilers (power plant), gasifiers and similar other facilities shall be detailed.

SEIAA, having gone through the recommendations of SEAC to issue ToR to the Existing project of M/S Super Smelters Limited at AddiBunglow Road, JhumriTelaiya, District - Koderma, Jharkhand, and the SEAC letter no.204 dated 24.11.2014 decides as follows-

- i. SEIAA agrees to the ToR in principle.
 - ii. SEIAA would consider the data generated by the project proponent only if it fulfils the requirement for the existing unit.
 - iii. M/S Super Smelters Limited, are therefore required to submit the data generated to prepare the EIA/EMP to SEIAA.
 - iv. SEIAA would consider issuing the ToR, once it satisfies itself vis-à-vis the appropriateness and applicability of the data generated already by the proponent, understandably in reference to their earlier proposal to obtain EC for the expansion and modernization of the existing unit, to the instant proposal.
 - v. SEIAA agrees to the recommendation of SEAC to waive the public hearing to be conducted afresh for the instant proposal.
10. Dr D. K. Saxena, IFS deputed as OSD to the SEIAA has undertaken journeys to Kolkata and New Delhi for the official purposes of SEIAA, as directed by Member Secretary, SEIAA Jharkhand. SEIAA approves the journeys undertaken by him under the instruction of Member Secretary, SEIAA. SEIAA also allows and approves the expenditure incurred by Dr D. K.
