

Minutes of the 64th Meeting of State level Environment Impact Assessment Authority, Jharkhand, held on 10th & 11th December, 2018.

The 64th meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 10/12/2018 and 11/12/2018 in the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

The decisions taken in the 64th SEIAA meeting are as follows:-

1. Hon'ble NGT Principal Bench, order dated-13.09.2018- regarding.

In the light of decision taken in 61st Meeting of SEIAA convened on 8th & 9th, October, 2018, the guidelines has been sought from Ministry of Environment, Forest and Climate Change, Govt. of India vide letter dated- 12.10.2018, 26.10.2018 and 30.10.2018 respectively.

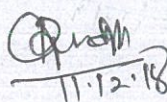
The Ministry of Environment, Forest and Climate Change, Govt. of India vide letter no-Z-11013/94/2008-IA II (M) dated-27.11.2018 has provided the guidelines wherein it has been mentioned that notification dated-25.07.2018 is prospective in operation.

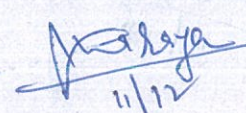
Authority has received a legal opinion in the light of guidelines issued by MoEF&CC, in which suggestion is given that a conditional Environmental Clearance could be issued after obtaining an affidavit from the project proponent that EC Granted subject to any further guidelines is issued in future by MoEF&CC, in compliance of Hon'ble NGT order dated-13.09.2018 in OA-186/2016, OA-200/2016, OA-580/2016, OA-102/2017, OA-404/2016, OA-405/2016 and OA-520/2016.

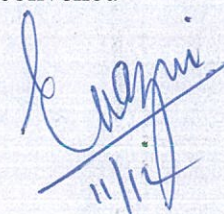
SEAC has also taken decision in its 64th Meeting convened on 4th and 5th December, 2018 and recommended the SEIAA to impose additional "conditions" as directed by Hon'ble NGT in the aforesaid order in anticipation of guidelines to be issued by MoEF&CC in future.

In view of aforesaid facts the Authority decided that project and applications with regard to minor minerals could be granted a conditional Environmental Clearance, subject to any further guidelines issued by MoEF&CC, and after obtaining an affidavit by PP to that effect. The Project Proponents will have to comply with all the directions and guidelines given by MoEF&CC, in compliance of said NGT order and if they fail to comply with the direction, the granted Environmental Clearance shall automatically stand revoked.

In view of the decision taken in 64th Meeting of SEIAA convened on 10th & 11th December, 2018, the earlier decision taken in 61st Meeting of SEIAA, convened on 08th & 9th October, 2018 stand modified to that extent.

2. SEIAA considered the recommendations made by SEAC in its 63rd meeting dated 05th & 06th November, 2018 for grant of Environmental Clearance.

- I. Expansion cum Modernization of M/s Mongia Steel Ltd. at Village – Burhiadin, Dist – Giridih.

It was decided to grant Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.

Proposed Expansion of Forgings from Existing capacity – Auto Components 3000 TPA Engineering Items 600 TPA, Export items (Auto Components + Engineering items) 75400 Nos./yr to Proposed capacity – Various Forings 60000 TPA. for Ramkrishna Forings Limited – Plant 1, at Plot M5 & M6, Phase – VI, Adityapur Industrial Area, Gamharia, Dist - Saraikela-Kharsawan, Jharkhand.

It was decided to grant ToR to the above mentioned project proposal with the conditions recommended by SEAC.

- II. Modification cum Expansion of existing Re-Rolling Mill of M/s Saluja Steel & Power (P) Ltd. at Mohanpur, Giridih.

It was decided to grant ToR to the above mentioned project proposal with the conditions recommended by SEAC.

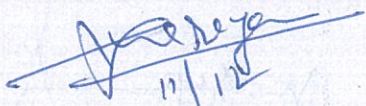
- III. Installation of 10 MW CPP based on WHRB & AFBC based technology integrating with existing 2x100 tpd DRi kiln of M/s Saluja Steel & Power (P) Ltd. at Mohanpur, Giridih.

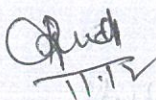
It was decided to grant ToR to the above mentioned project proposal with the conditions recommended by SEAC.

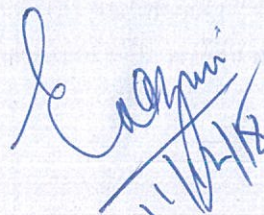
4. SEIAA considered the recommendations made by SEAC in its 64th meeting dated 04th & 05th December, 2018.

It was decided to grant Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.

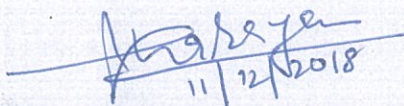

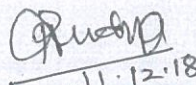
6. Wages of Daily wagers (Driver & 4th Grade Staff) regarding.

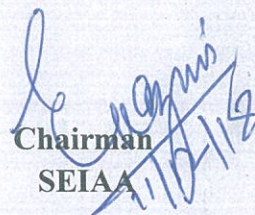
