

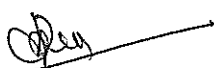
**MINUTES OF THE 118<sup>TH</sup> MEETING OF STATE LEVEL ENVIRONMENT

The SEAC has appraised the above projects in the light of Hon'ble NGT order dated 13.09.2018, dated 11.12.2018 and MoEF & CC, OM dated 12.12.2018. SEAC has made unanimous recommendations for grant of Environmental Clearances of above mentioned project proposals. The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearances to the above mentioned project proposals with following specific conditions:

- i. Project Authority will ensure that personal protective equipments such as protective clothing, helmet, goggles or other garments or equipments designed to protect from injury or infection will be provided to working personnel's.
- ii. In compliance of OM No. F.No. IA3-22/3/2024-IA.III (E-241594) dated 24.07.2024 of MoEF&CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign "*Ek Ped Ma Ke Naam*" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>).
- iii. The Deputy Commissioner through District Mining Officer will ensure that the mines owner of the respective leases to complete the plantation and maintenance in a time bound manner.
- iv. Suitable plant species of not less than 2 M height to be planted equal to twice the area of saplings proposed in Safety zone. This is to be planted in land available near mines and outside safety zone. This will be in addition to plantation in



safety zone. Newly planted saplings to be maintained for minimum 3 years with Geo-Tagged photographs.

- v. Dedicated water tanker to be provided for mine. The tanker to be used for spraying water on haul road and for irrigating newly planted saplings only. Sprinkling to be done such that the haul road is kept moistened all the time with Geo-Tagged photographs.
- vi. Pre employment Occupational health check up for employees to be done and thereafter at annual interval for PLFT, Audiometry and other required tests . Summary findings of same to be submitted along with 6 monthly compliance.
- vii. Ensure use of Quality PPEs equivalent not less than 3M make. Records of same to be maintained and submitted with 6 monthly compliance report with Geo-Tagged photographs.
- viii. Keep vulnerable areas unmanned. Ensure rotation of duties. Records to be maintained and submitted with 6 monthly compliance report.
- ix. Failing of any of terms & conditions mentioned in EC can lead to revocation / cancellation of EC.

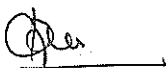

The SEAC has appraised the above projects in the light of Hon'ble NGT order dated 13.09.2018, dated 11.12.2018 and MoEF & CC, OM dated 12.12.2018. SEAC has made unanimous recommendations for grant of Environmental Clearances of above mentioned project proposals. The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearances to the above mentioned project proposals with following specific conditions:

- i. Project Authority will ensure that personal protective equipments such as protective clothing, helmet, goggles or other garments or equipments designed to protect from injury or infection will be provided to working personnel's.
- ii. During appraisal of the project it is seen that the project authority have not fully complied the condition of green belt development as per the previous EC. Hence, the project authorities are required to plant twice the number of trees as was required in the previous EC.

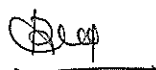

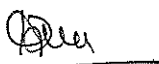

- iv. Replenishment study shall be conducted during pre-monsoon and post monsoon every year and study report have to be submitted to SEIAA / SEAC, Jharkhand. The production shall be restricted to 60% of the replenished quantity or the proposed quantity in the mine plan, which ever is less.
- v. Suitable plant species of not less than 2 M height to be planted in area equal to twice the area of saplings proposed in Safety zone. This is to be planted in land available near mines and outside safety zone. This will be in addition to plantation in safety zone. Newly planted saplings to be maintained for minimum 3 years with Geo-Tagged photographs.
- vi. Dedicated water tanker to be provided for spraying water on haul road and for irrigating newly planted saplings only. Sprinkling to be done such that the haul road is kept moistened all the time with Geo-Tagged photographs.



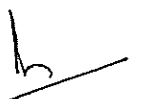

- vii. Pre-employment Occupational health checkup for employees to be done and thereafter at annual interval for PLFT, Audiometry and other required tests. Summary findings of same to be submitted along with 6 monthly compliance.
- viii. Ensure use of Quality PPEs equivalent not less than 3M make. Records of same to be maintained and submitted within 6 monthly compliance report with Geo-Tagged photographs.
- ix. Keep vulnerable areas unmanned. Ensure rotation of duties. Records to be maintained and submitted within 6 monthly compliance report.
- x. Failing of any of terms & conditions mentioned in EC can lead to revocation / cancellation of EC.
- xi. Project Authority will ensure that personal protective equipments such as protective clothing, helmet, goggles or other garments or equipments designed to protect from injury or infection will be provided to working personnel's.
- xii. River Sand Mining shall not be done in rainy Season (mid June to mid October of each calendar year).
- xiii. Dept. of Mines & Geology, Govt. of Jharkhand shall keep a strict vigil in the compliance of relevant provisions of applicable Jharkhand Minerals (Prevention of illegal mining, Transportation and Storage) Rule 2017 and its amendment especially scientific execution of mining plan (as approved by them themselves) and report violations if any is found as well as action taken for the same.
- xiv. Project Proponent shall submit (to the SEIAA, Jharkhand, Regional Office of MoEF&CC at Ranchi, Jharkhand State Pollution Control Board) six monthly compliance report with evidence of the conditions within a fortnight after the end of every six month till validity period of Environmental Clearance.
- xv. The project proponent before starting any activity / preparation of ground, on the leased area shall demarcate his lease hold by RCC pillars erected at the cost of lease holder after certification of the mining officer. On each pillar Geo-Coordinate and fore bearing / back bearing shall be written with permanent paint mark as described in the mining plan. All the pillars should remain intact at same geo-coordinate. Establishment / labeling of Benchmark at each pillars or ground control points.
- xvi. Extraction of sand beyond annual production capacity is not permitted.
- xvii. The Project Proponent should undertake the sand mining limited to 03 meter (three meter) depth by exclusively manual method.
- xviii. The stacking area of mined-out sand which shall be situated near the mining site within a fenced area from all sides to avoid being spread in the nearby areas by high winds and the height of stacking should not exceed 2 meter. 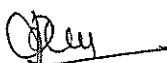

- xxii. Provision shall be made for housing labour with all necessary infrastructure and facilities (outside mining Block and river-bed) such as fuel for cooking, toilets / mobile toilets, safe drinking water, First-Aid facilities, crèche etc. The housing may be in the form of temporary structures to be removed after the completion of the project.
- xxiii. Labour & Personnel working in dusty areas shall wear protective respiratory devices and they shall also be provided with adequate training and information on safety and health aspects. Occupational health surveillance program of the workers shall be undertaken periodically to observe any adverse health impact due to exposure to dust and take corrective measures, if needed.
- xxiv. The Project Proponent shall make arrangements for safe drinking water, first aid facility along with anti-venom injection, in case of emergency for the workers.
- xxv. Sand and gravel may be extracted across the entire active channel during the dry season.

Sand and gravel shall not be extracted up to a distance of 1 kilo meter (1 km.) from major bridges and highways on both sides, of five times (5x) of the span (x) of a bridge / public civil structure (including water intake points) on up-stream side and ten times (10x) the span of such bridge on down-stream side, subjected to a minimum of 250 meters on the upstream side and 500 meters on the downstream side.
- xxx. Sand and gravel could be extracted from the downstream of the sand bar at river bends.
- xxxi. Mining depth should be restricted to 3 meters and distance from the band should be  $1/4^{\text{th}}$  of river width and should not be less than 7.5 meters.
- xxxii. A buffer distance / unmined block of 50 meters after every block of 1000 meters over which mining is undertaken or at such distance as may be the directed / prescribed by the regulatory authority shall be maintained.
- xxxiii. River bed sand mining shall be restricted within the central  $3/4^{\text{th}}$  width of the river/rivulet of 7.5 meters (inward) from river banks but up to 10% of the width of the river, as the case may be. Regulating authority while regulating the zone of river bed mining shall ensure that the objective to minimize the effects of riverbank erosion and consequential channel migration are achieved to the extent possible. In general, the area for removal of minerals shall not exceed 60% of the mine lease area, and any deviation of relaxation in this regard shall be adequately supported by the scientific report.

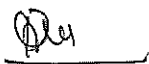

The Divisional Forest Officer, Giridih East Forest Division has stated that *F(C) Act, 1980 does not attracts in this project as per consolidated Guidelines and clarification issued under VAN (SANRAKSHAN EWAM SAMVARDHAN) ADHINIYAM 1980 AND VAN (SANRAKSHAN EWAM SAMVARDHAN) RULES 2023 in Chapter – 1 Para 1.3 (i) has clearly mentioned the following:-*

*“ Supreme Court order dated 07.05.1985: State of Bihar Vs Bansi Ram Modi & Ors. in the Hon’ble Supreme Court of India: We are, therefore, of the view that while before granting permission to start mining operations on a virgin area section 2 of the Act has to be complied with it is not necessary to seek the prior approval of the Central Government for purposes of carrying out mining operations in a forest area which is broken up or cleared before the commencement of the Act”.*

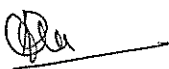

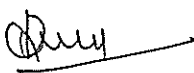

The SEIAA, based on the recommendation of SEAC, unanimously decided to grant ToRs to the above mentioned project proposals with the conditions recommended by SEAC and alongwith the following specific conditions:

F.No. IA3-22/3/2024-IA.III (E-241594) dated 24.07.2024 of MoEF & CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign "*Ek Ped Ma Ke Naam*" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>).

SEAC has made unanimous recommendations for grant of ToR to above mentioned proposal. The SEIAA, based on the recommendation of SEAC, unanimously decided to grant ToR to the above mentioned project proposal with the conditions recommended by SEAC and alongwith the following specific conditions:

- i. In compliance of OM no. F.No. IA3-22/3/2024-IA.III (E-241594) dated 24.07.2024 of MoEF & CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign "*Ek Ped Ma Ke Naam*" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>).
- ii. The plot no. 230/1277 is being not considered at this stage as in the approved mine plan plot no. 230/1227 has been given in place of 230/1277. Therefore, PP needs to provide proper justification from competent authority in this regard with final EIA / EMP report.

9. SEIAA considered the Recommendations of SEAC in its 118<sup>th</sup> meeting held on 22<sup>nd</sup>, 23<sup>rd</sup>, 24<sup>th</sup>, 25<sup>th</sup> and 26<sup>th</sup> October, 2024 for grant of Terms of Reference (ToR) to the following Coal Washery project:

- i. Proposed Green Field Project to Set-up wet 2.48 MTPA Coal Washery by M/s Omkar Coal Washeries Pvt. Ltd., Village : Olhepat, Tehsil : Balumath, Distt.: Latehar, Jharkhand (7.48 Ha). (Proposal no.: SIA/JH/CMIN/500925/2024).

SEAC has appraised the above project and made unanimous recommendations for grant of ToR to above mentioned proposal. The SEIAA, based on the recommendation of SEAC, unanimously decided to grant ToR to the above mentioned project proposal with the conditions recommended by SEAC and alongwith the following specific conditions:

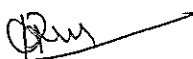
- i. In compliance of OM no.F.No. IA3-22/3/2024-IA.III (E-241594) dated 24.07.2024 of MoEF&CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign “*Ek Ped Ma Ke Naam*” and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>).
- ii. Complete material balance including the media and flocculants to be provided.
- iii. Detailed water balance to be provided. Rain Water Harvested is also to be included.

- x. Management plan for the railway siding to be specifically detailed.
- xi. Undertaking for implementation of ZLD is to be incorporated in EIA report.

10. SEIAA considered the recommendations made by SEAC in its 118<sup>th</sup> meeting held on 22<sup>nd</sup>, 23<sup>rd</sup>, 24<sup>th</sup>, 25<sup>th</sup> and 26<sup>th</sup> October, 2024 for revoke to the following project.

- i. Stone Mine of M/s Cegnet Stone Works, Village : Jiajori, Thana no. : 63, Thana : Hiranpur, Distt.: Pakur, Jharkhand (2.36 Ha). (Proposal no.: SIA/JH/MIN/502018 /2024).

The SEAC considered the above mentioned project for appraisal and forwarded following recommendation to SEIAA in this matter:-

*“The project has been granted EC by DEIAA, Pakur vide letter no. 167/DEIAA dated 09.09.2017.*

*As per O.M. dated 28<sup>th</sup> April 2023 issued by MOEF & CC projects which have been granted EC by DEIAA are to be reappraised by SEIAA / SEAC.*

*This is re-appraisal of the EC issued by DEIAA, Pakur which has been taken up for consideration on 25.10.2024. As per O.M. dated 12.12.18 issued by MOEF & CC projects fall in category B1.*

*During appraisal it was found that the project authorities have already obtained EC from SEIAA, Jharkhand vide letter no. EC/SEIAA/2023-24/2936/2023/286, dated 06.10.2023 under B2 category based on cluster certificate issued by DMO, Pakur vide memo no. 1693/M, dated 22.07.2023 stating that no other mine lease exists in the cluster. Hence area of the cluster stated as 5.83 acres (2.35 Ha) which is the same area of this project.*

*Now the project authorities have made a fresh application bearing proposal no. SIA/JH/MIN /502018/2024 for consideration of the project under DEIAA to SEIAA re-appraisal of EC. The current cluster certificate from DMO, Pakur vide memo no. 1398/M dated 02.09.2024 states that one more mine (lease period 26.02.2016 for a period of 10 years) exists within the cluster and hence the total cluster area specified as 17.60 acres (7.12 Ha.).*

*The project authorities have concealed the fact that they have already obtained EC from SEIAA vide letter no. EC/SEIAA/2023-24/2936/2023/286, dated 06.10.2023 under B2 category.*

*As per the present DMO certificate the other mine in the cluster is in existence since 26.02.2016. Hence, the credibility of the earlier DMO certificate issued vide memo no. 1693/M, dated 22.07.2023 is doubtful.*

*In view of the above the SEAC is of the opinion that the project authorities have made application to SEIAA / SEAC manipulating and concealing the actual facts.*

*Therefore, the Committee recommends revoking the earlier ECs issued to the project and initiate necessary action as applicable”.*

**SEIAA examined the recommendation of SEAC in the light section 8(vi) of the EIA notification, 2006 and unanimously decided to authorize Member Secretary, SEIAA to issue a show cause to the project Authority for explaining his conduct in this matter and outcome of the case will again put up before SEIAA for final decision.**

**11. Final District Survey Report (DSR) for Minor Minerals other than Sand Mining or River Bed Mining (Stone and Earth Work) to be approved on Ranchi District.**

**I. District Survey Report (Stone and Earth Work) of Ranchi district**

After Technical presentation before SEAC and appraisal of DSR, the unanimous recommendation was sent to SEIAA for approval of District Survey Report for Minor Minerals other than Sand Mining or River Bed Mining (Stone and Earth Work) of **Ranchi** district, as the District Survey Report (Stone and Earth Work) contained all

relevant information required as per the notification no. **S.O. 3611(E)**, dated **25.07.2018** of MoEF & CC, Govt. of India.

In the light of the recommendation of SEAC for approval of District Survey Report for Minor Minerals other than Sand Mining or River Bed Mining (Stone and Earth Work) of **Ranchi** district, the same was considered in the **118<sup>th</sup>** meeting of SEIAA, Jharkhand on **28.11.2024** and **29.11.2024**.

The SEIAA, unanimously, decided to approve the District Survey Report (DSR) for Minor Minerals other than Sand Mining or River Bed Mining (Stone and Earth Work) of **Ranchi** district on the basis **recommendation** of **SEAC**. It was also decided that a copy of approved District Survey Report of Stone and Earth Work should be sent to the concerned Deputy Commissioner for onward necessary action.

## **12. Transfer of Environmental Clearance regarding:**

- I. **Misraul Stone Mine of Shri Vinay Kumar Singh** at Village : Misraul, P.O. : Tapej, P.S. : Chatra (No.- 271), District : Chatra, Jharkhand (1.15 Ha) (Proposal No. : SIA/JH/MIN/501849/2024).

The above mentioned project proposal was considered in the light of section 11 of Environment Impact Assessment Notification, 2006 for transferability of Environmental Clearance. The Environmental Clearance was granted by **SEIAA, Jharkhand** vide letter no. **EC/SEIAA/2018-19/2168/2019/540**, dated **09.10.2019** in the favor of "**Misraul Stone Mine of M/s Maa Suruchi Stone Works (Prop.: Shri Kalicharan Singh)**" at Khata No.- 01, 12, 26, 33, Plot No.- 250(P), 245, 214(P), 243 at Village : Misraul, P.O. : Tapej, P.S. : Chatra, District : Chatra, Jharkhand (1.15 Ha) (Proposal No. : SIA/JH/MIN/42058/2019)".

The applicant vide online application no. **SIA/JH/MIN/501849/2024** has requested to transfer (transfer of ownership) of Environmental Clearance in favour of "**Misraul Stone Mine of Shri Vinay Kumar Singh**" for which he has submitted "No Objection Certificate" affirming that the Environmental Clearance will be transferred in favour of "**Misraul Stone Mine of Shri Vinay Kumar Singh**" and they do not have any objections regarding the transfer of Environmental Clearance and all the terms and conditions of Environmental Clearance dated **09.10.2019** shall be complied by "**Misraul Stone Mine of Shri Vinay Kumar Singh**". Deputy Commissioner, Chatra has also transferred the lease deed vide **GRN Number : 2404168412** in the favour of "**Misraul Stone Mine of Shri Vinay Kumar Singh**".

After the full deliberations, it was unanimously decided that Environmental Clearance issued vide letter no. **EC/SEIAA/2018-19/2168/2019/540**, dated **09.10.2019** is being transferred to "**Misraul Stone Mine of Shri Vinay Kumar Singh**" with the same terms and conditions under which prior Environmental Clearance was granted by SEIAA, Jharkhand for the same validity period subject to satisfactory compliance to all stipulated terms and conditions. "**Misraul Stone Mine of Shri Vinay Kumar Singh**" is

directed to obtain **Consent to Operate** from the State Pollution Control Board in the name of "*Misraul Stone Mine of Shri Vinay Kumar Singh*" In case any change is proposed in the Scope of the project, the Project Authority (PA) shall obtain fresh Environmental Clearance.
