

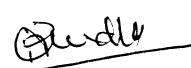
**MINUTES OF THE 121ST MEETING OF STATE LEVEL ENVIRONMENT

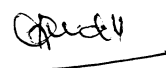

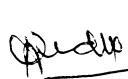

The SEAC has appraised the above projects in the light of Hon'ble NGT order dated 13.09.2018, dated 11.12.2018 and MoEF & CC, OM dated 12.12.2013. SEAC has made unanimous recommendations for grant of Environmental Clearances of above mentioned project proposals. The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearances to the above mentioned project proposals with following specific conditions:

- i. Project Authority will ensure that personal protective equipments such as protective clothing, helmet, goggles or other garments or equipments designed to protect from injury or infection will be provided to working personnel's.
- ii. In compliance of OM no.F.No. IA3-22/3/2024-IA.III (E-241594) dated 24.07.2024 of MoEF&CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign "EkPed Ma KeNaam" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>). 10% of the total green belt proposed shall be allocated under this clause.
- iii. The Deputy Commissioner through District Mining Officer will ensure that the mines owner of the respective leases to complete the plantation and maintenance in a time bound manner.
- iv. Suitable plant species of not less than 2 M height to be planted equal to twice the area of saplings proposed in Safety zone. This is to be planted in land available near mines and outside safety zone. This will be in addition to plantation in



safety zone. Newly planted saplings to be maintained for minimum 3 years with Geo-Tagged photographs.

- v. Dedicated water tanker to be provided for mine. The tanker to be used for spraying water on haul road and for irrigating newly planted saplings only. Sprinkling to be done such that the haul road is kept moistened all the time with Geo-Tagged photographs.
- vi. Pre employment Occupational health check up for employees to be done and thereafter at annual interval for PLFT, Audiometry and other required tests . Summary findings of same to submitted along with 6 monthly compliance.
- vii. Ensure use of Quality PPEs equivalent not less than 3M make. Records of same to be maintained and submitted with 6 monthly compliance report with Geo-Tagged photographs.
- viii. Keep vulnerable areas unmanned. Ensure rotation of duties. Records to be maintained and submitted with 6 monthly compliance report.
- ix. Failing of any of terms & conditions mentioned in EC can lead to revocation / cancellation of EC.

The SEAC has appraised the above projects in the light of Hon'ble NGT order dated 13.09.2018, dated 11.12.2018 and MoEF & CC, OM dated 12.12.2018. SEAC has made unanimous recommendations for grant of Environmental Clearances of above mentioned project proposals. The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearances to the above mentioned project proposals with following specific conditions:

- i. The above projects are not specifically mentioned in the approved DSR of Sahibganj district in chapter 13.



DMO, Sahibganj vide letter no. 431, dated 11.03.2025 requested that due to inadvertent mistakes the above projects have not been specifically mentioned in the approved DSR of Sahibganj district in chapter 13. He further requested to consider the above said project proposals as a part of chapter 13 (LOI holder list in the districts) of approved District Survey Report and these projects may be taken up for consideration for grant of Environmental Clearances.

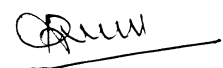
The request of DMO, Sahibganj has been accepted by the SEAC, Jharkhand and accordingly recommended for grant of EC. The SEIAA is of the view that Environmental Clearance (EC) of the above proposals are being granted considering all the facts and recommendation that all the project proposals lies within the potential villages of mining in the approved District Survey Report. SEIAA also decided that Deputy Commissioner, Sahibganj may take further action with regard to incorporation of above project proposals in the District Survey Report of Sahibganj.

- ii. Project Authority will ensure that personal protective equipments such as protective clothing, helmet, goggles or other garments or equipments designed to protect from injury or infection will be provided to working personnel's.
- iii. In compliance of OM no.F.No. 1A3-22/3/2024-1A.III (E-241594) dated 24.07.2024 of MoEF&CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign "EkPed Mu KeNaam" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>). 10% of the total green belt proposed shall be allocated under this clause.

- xi. Failing of any of terms & conditions mentioned in EC can lead to revocation / cancellation of EC.
- xii. Project Authority will ensure that personal protective equipments such as protective clothing, helmet, goggles or other garments or equipments designed to protect from injury or infection will be provided to working personnel's.
- xiii. River Sand Mining shall not be done in rainy Season (mid June to mid October of each calendar year).
- xiv. Dept. of Mines & Geology, Govt. of Jharkhand shall keep a strict vigil in the compliance of relevant provisions of applicable Jharkhand Minerals (Prevention of illegal mining, Transportation and Storage) Rule 2017 and its amendment especially scientific execution of mining plan (as approved by them themselves) and report violations if any is found as well as action taken for the same.
- xv. Project Proponent shall submit (to the SEIAA, Jharkhand, Regional Office of MoEF&CC at Ranchi, Jharkhand State Pollution Control Board) six monthly compliance report with evidence of the conditions within a fortnight after the end of every six month till validity period of Environmental Clearance.
- xvi. The project proponent before starting any activity / preparation of ground, on the leased area shall demarcate his lease hold by RCC pillars erected at the cost of lease holder after certification of the mining officer. On each pillar Geo-Coordinate and fore bearing / back bearing shall be written with permanent paint mark as described in the mining plan. All the pillars should remain intact at same geo-coordinate. Establishment / labeling of Benchmark at each pillars or ground control points.
- xvii. Extraction of sand beyond annual production capacity is not permitted.
- xviii. The Project Proponent should undertake the sand mining limited to 03 meter (three meter) depth by exclusively manual method.
- xix. The stacking area of mined-out sand which shall be situated near the mining site within a fenced area from all sides to avoid being spread in the nearby areas by high winds and the height of stacking should not exceed 2 meter. Transportation shall be confined to day time only that is from sunrise to sunset, to avoid inconvenience to local population in any manner.
- xx. Mining activity shall not be done for mine lease where mining can cause danger to site of flood protection works, places of cultural, religious, historical and archaeological importance.



- xxi. Project Proponent shall submit the annual replenishment report certified by an authorized agency.
- xxii. No labour camp shall be allowed in riverbed.
- xxiii. Provision shall be made for housing labour with all necessary infrastructure and facilities (outside mining Block and river-bed) such as fuel for cooking, toilets / mobile toilets, safe drinking water, First-Aid facilities, crèche etc. The housing may be in the form of temporary structures to be removed after the completion of the project.
- xxiv. Labour & Personnel working in dusty areas shall wear protective respiratory devices and they shall also be provided with adequate training and information on safety and health aspects. Occupational health surveillance program of the workers shall be undertaken periodically to observe any adverse health impact due to exposure to dust and take corrective measures, if needed.
- xxv. The Project Proponent shall make arrangements for safe drinking water, first aid facility along with anti-venom injection, in case of emergency for the workers.
- xxvi. Sand and gravel may be extracted across the entire active channel during the dry season.
- xxvii. Abandoned stream channels on the terrace and inactive floodplains be preferred rather than active channels and their deltas and flood plains. The stream should not be diverted to form the inactive channel.
- xxviii. Layers of sand and gravel which could be removed from the river bed shall depend on the width of the river and replenishment rate of the river.
- xxix. Sand and gravel shall not be allowed to be extracted where erosion may occur, such as at the concave bank.
- xxx. Sand and gravel shall not be extracted up to a distance of 1 kilo meter (1 km.) from major bridges and highways on both sides, of five times (5x) of the span (x) of a bridge / public civil structure (including water intake points) on up-stream side and ten times (10x) the span of such bridge on down-stream side, subjected to a minimum of 250 meters on the upstream side and 500 meters on the downstream side.
- xxxi. Sand and gravel could be extracted from the downstream of the sand bar at river bends.
- xxxii. Mining depth should be restricted to 3 meters and distance from the band should be $1/4^{\text{th}}$ of river width and should not be less than 7.5 meters.
- xxxiii. A buffer distance / unmined block of 50 meters after every block of 1000 meters over which mining is undertaken or at such distance as may be the directed / prescribed by the regulatory authority shall be maintained.
- xxxiv. River bed sand mining shall be restricted within the central $3/4^{\text{th}}$ width of the river/rivulet of 7.5 meters (inward) from river banks but up to 10% of the width of the river, as the case may be. Regulating authority while regulating the zone of river bed mining shall ensure that the objective to minimize the effects of riverbank erosion and consequential channel migration are achieved to the extent possible. In general, the area for removal of minerals shall not exceed 60% of the



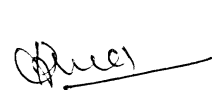
mine lease area, and any deviation of relaxation in this regard shall be adequately supported by the scientific report.

The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearances to the above mentioned project proposal with following specific conditions:

- i. Project Authority will ensure that personal protective equipments such as protective clothing, helmet, goggles or other garments or equipments designed to protect from injury or infection will be provided to working personnel's.
- ii. In compliance of OM no.F.No. IA3-22/3/2024-IA.III (E-241594) dated 24.07.2024 of MoEF&CC, Govt. of India plantation of saplings shall be carried out in the earmarked green belt area as the part of tree plantation campaign "EkPed Ma KeNaam" and the details of the same shall be uploaded in the MeriLiFE Portal (<https://merilife.nic.in>). 10% of the total green belt proposed shall be allocated under this clause.

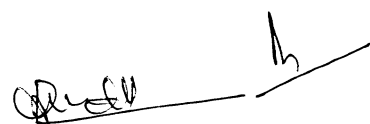

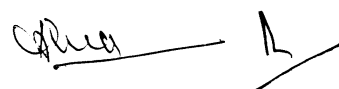

16. Decision on the matter related to Member Secretary, JSPCB, Ranchi Ref. no. 344, dated 18.02.2025 regarding seeking guidance on the ToR issued to the units mentioned in Pakur Region:

The SEAC in its 121st meeting held on 08th, 09th, 10th, 11th and 12th March, 2025 considered the same and forwarded the observations in the instant matter:

"The application for issuance of ToR was submitted to SEAC within the validity of DSR.

Hence, as the DSR was valid at the time of receipt of application on PARIVESH Portal by SEAC, it was considered for grant of ToR.

Accordingly, the issuance of ToR fulfils all the requisite norms".

The above recommendation of SEAC is self-explanatory. Hence, SEIAA unanimously decided to send the required clarification to Member Secretary, Jharkhand State Pollution Control Board for information.

17. Transfer of Environmental Clearance regarding:

1. Mayurkola Stone Mine of M/s Maa Ambika Minerals Pvt. Ltd (Director : Shri Subrato Paul), Village : Mayurkola, P.S. : Kotalpokhar, District : Sahibganj, Jharkhand (2.86 Ha) (Proposal no.: SIA/JH/MIN/ 530110 /2025).

The above mentioned project proposal was considered in the light of section 11 of Environment Impact Assessment Notification, 2006 for transferability of Environmental Clearance. The Environmental Clearance was granted by DEIAA, Jharkhand vide letter no. EC/DEIAA/2017-18/56, dated 21.06.2017 in the favor of "M/s Sky Stone Works, (Prop : Shri Premchandra Haswani) at Khata No. : 208, Plot No. : 752, 753, 754, 755, 756, 761, 762, 763, 764, 766, 767, 768, 769, 770 & 771 at Mouza : Mayurkola, P.O. : Mayurkola, P.S. : Kotalpokhar, Dist. : Sahibganj, Jharkhand (2.86 Ha / 7.07 Acres)".

The applicant vide online application no. SIA/JH/MIN/530110 /2025 has requested to transfer (transfer of ownership) of Environmental Clearance in favour of "Mayurkola Stone Mine of M/s Maa Ambika Minerals Pvt. Ltd." for which he has submitted "No Objection Certificate" affirming that the Environmental Clearance will be transferred in



favour of **"Mayurkola Stone Mine of M/s Maa Ambika Minerals Pvt. Ltd"** and they do not have any objections regarding the transfer of Environmental Clearance and all the terms and conditions of Environmental Clearance dated **21.06.2017** shall be complied by **"Mayurkola Stone Mine of M/s Maa Ambika Minerals Pvt. Ltd."**. Deputy Commissioner, Sahibganj has also transferred the lease deed No. **2023/RAJM/3766/BK1/3711** Dated : **26/09/2023** and GRN Number : **2319437887** in the favour of **"Mayurkola Stone Mine of M/s Maa Ambika Minerals Pvt. Ltd."**.

After the full deliberations, it was unanimously decided that Environmental Clearance issued vide letter no. **EC/DEIAA/2017-18/56**, dated **21.06.2017** is being transferred to **"Mayurkola Stone Mine of M/s Maa Ambika Minerals Pvt. Ltd."** with the same terms and conditions under which prior Environmental Clearance was granted by **DEIAA, Jharkhand** for the same validity period subject to satisfactory compliance to all stipulated terms and conditions. **"Mayurkola Stone Mine of M/s Maa Ambika Minerals Pvt. Ltd."** is directed to obtain **Consent to Operate** from the State Pollution Control Board in the name of **"Mayurkola Stone Mine of M/s Maa Ambika Minerals Pvt. Ltd."** In case any change is proposed in the Scope of the project, the Project Authority (PA) shall obtain fresh **Environmental Clearance**.

18. Any other matter:

- I. **Telodih Stone Deposit of M/s Ram Janki Stone Works of Shri Om Prakash Barnwal** at Khata No. – 31, Plot No. - 78 (P), 84 to 86, 90 (P), 1518 to 1520, 1522, 1523 (P), 1524, 1527, 1530, 1531, 1532 (P), 1535 (P), 1536, 1537 (P), 1540 (P), 1490 to 1494, 1498, 1499, 1500 (P), 1512, 1513 (P), 1514, 1515, 1596 (P), 1598 & 1610 (P) at Village – Telodih, P.S. – Giridih, District – Giridih, Jharkhand (Area – 11.90 Acres / 4.816 Ha).

- i. The project proponent Shri Om Prakash Barnwal has submitted application on 02.03.2015 for grant of Environmental Clearance of the stone mining project i.e. **Telodih Stone Deposit of M/s Ram Janki Stone Works of Shri Om Prakash Barnwal** at Khata No. – 31, Plot No. - 78 (P), 84 to 86, 90 (P), 1518 to 1520, 1522, 1523 (P), 1524, 1527, 1530, 1531, 1532 (P), 1535 (P), 1536, 1537 (P), 1540 (P), 1490 to 1494, 1498, 1499, 1500 (P), 1512, 1513 (P), 1514, 1515, 1596 (P), 1598 & 1610 (P) at Village – Telodih, P.S. – Giridih, District – Giridih, Jharkhand (Area – 11.90 Acres / 4.816 Ha) with all requisite documents such as Form-I, P.F.R., Mine Plan and other statutory documents like NOC given by Gram Sabha, the relevant certificates issued by CO, DMO and DFO. One of the criteria for requirement of Environmental Clearance is the distance from forest boundary should be minimum 250 meter.
- ii. Then DFO, Giridih East Division, Giridih issued the certificate regarding the distance from forest boundary and mining lease vide its letter no. 912, dated



13.05.2014, in which it was mentioned that the distance of boundary of mining lease area from notified forest boundary is 260 meter.

- iii. On the basis of aforesaid and alongwith other mandatory documents, the project proposal was appraised by then SEAC in its 27th meeting (Part B) held on 24th to 27th March, 2015 and project was recommended for Environmental Clearance. In the light of recommendation of SEAC Environmental Clearance was granted by the then SEIAA in its 31st meeting held on 27th may, 2015. Accordingly EC letter was issued vide letter no. : EC/SEIAA/2014-15/676/2015/1047, dated : 09.06.2015 with certain conditions.
- iv. The present DFO, Giridih East Division, Giridih vide its letter no. : 3161, dated : 19.09.2024 has made a complaint that actual distance of mining lease area of Stone Mine of **Telodih Stone Deposit of M/s Ram Janki Stone Works of Shri Om Prakash Barnwal** at Khata No. – 31, Plot No. - 78 (P), 84 to 86, 90 (P), 1518 to 1520, 1522, 1523 (P), 1524, 1527, 1530, 1531, 1532 (P), 1535 (P), 1536, 1537 (P), 1540 (P), 1490 to 1494, 1498, 1499, 1500 (P), 1512, 1513 (P), 1514, 1515, 1596 (P), 1598 & 1610 (P) at Village – Telodih, P.S. – Giridih, District – Giridih, Jharkhand (Area – 11.90 Acres / 4.816 Ha) is only zero(0) meter and requested to cancel the Environmental Clearance.
- v. After receiving the complaint from DFO, Giridih East Division, Giridih vide its letter no. 3161, dated : 19.09.2024, a show cause notice was issued to project Authority, Shri Om Prakash Barnwal vide SEIAA letter no. : 279, dated : 15.10.2024 and again vide letter no. : 332, dated : 06.11.2024. Project Authority Shri Om Prakash Barnwal submitted his reply of show cause vide its letter no. zero, dated 19.11.2024 requesting that a joint site inspection shall be carried out in presence of project Authority Shri Om Prakash Barnwal and DFO, Giridih East Forest Division to ascertain the actual distance from mining lease area to forest boundary.
- vi. After receiving the show cause reply from project authority Shri Om Prakash Barnwal the Member Secretary, SEIAA written a letter to DFO, Giridih East Forest Division vide its letter no. 336, dated 26.11.2024 with direction that a joint site inspection shall be carried out in presence of project Authority Shri Om Prakash Barnwal and DFO, Giridih East Forest Division to ascertain the actual distance from mining lease area to forest boundary.
- vii. The DFO, Giridih East Forest Division after making various efforts conducted a joint inspection on 05.02.2025 at 11:00 AM in presence of Project Authority Shri



Om Prakash Barnwal and forwarded its report to SEIAA vide letter no. 324, dated 11.02.2025. After perusal of report it reflects that mining plot no. 90 (P) is at zero(0) meter from notified forest land and 251 meter from demarcated forest.

- viii. Simultaneously Project Authority Shri Om Prakash Barnwal has again requested vide its letter no. zero, dated 24.02.2025 that he will be allowed to operate the mines on remaining area after fulfilling the minimum distance criteria of 250 meter from forest boundary and that EC letter No. - EC/SEIAA/2014-15/676/2015/1047, dated : 09.06.2015 should not be revoked.

In the light of aforesaid facts SEIAA unanimously decided that Shri Om Prakash Barnwal will be allowed to submit the revised proposal through Parivesh Portal with all the requisite documents alongwith criteria of 250 meters from forest boundary to obtain the Amended Environmental Clearance.
