in DMO office. Then mining lease should not have been executed and should not allow the execution of mining operation which has been carried on for years.

• The DMO, Pakur is solely responsible for issuing a contiguous / cluster certificate to the lessee and also the lease should be executed on the basis of correct contiguous / cluster certificate.

Accordingly, Deputy Commissioner, Pakur should take cognizance of memo no. 149, dated 12.07.2024 of SEIAA to take appropriate action against the project proponent/ erring officials under the relevant Acts and Rules.

Accordingly, SEIAA may communicate the above observation of SEAC to Deputy Commissioner, Pakur".

SEIAA considered the recommendation of SEAC as mentioned above and unanimously decided that Deputy Commissioner, Pakur should take cognizance of memo no. 149, dated 12.07.2024 of SEIAA to take appropriate action against the project proponent / erring officials under the relevant Acts and Rules.
