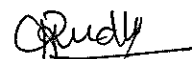
The decisions taken in the 125th SEIAA meeting are as follows:-

1. SEIAA considered the recommendations made by SEAC in its 125th meeting held on 23rd, 24th, 25th, 26th, 27th and 28th July, 2025 for grant of Environmental Clearance to the following Minor Mineral (Stone Mining) projects:

- I. Karmatand Stone Deposit of M/s Giridhar Sujh Enterprises (Partner : Shri Jitendra Kumar Rajak), Village : Karmatand, Thana : Gandey, Distt. : Giridih, Jharkhand (1.16 Ha) (Proposal no.: SIA/JH/MIN/ 538412 /2025).

(Director : Shri Pranay Kumar Sahu)**” and they do not have any objections regarding the transfer of Environmental Clearance and all the terms and conditions of Environmental Clearance dated 20.11.2014 shall be complied by “**M/s Mahaveer Engicons Pvt. Ltd. (Director : Shri Pranay Kumar Sahu)**”. Deputy Commissioner, Sahibganj has also transferred the lease deed vide GRN Number : 2501549291 , dated : 03.04.2025 in the favour of “**M/s Mahaveer Engicons Pvt. Ltd. (Director : Shri Pranay Kumar Sahu)**”. District Mining Officer, Sahibganj vide Memo No. : 1323/M dated : 14.07.2025 certified that the said project situated at grid no. 3 and production of said mining project is under permissible limit of that grid.

After the full deliberations, it was unanimously decided that Environmental Clearance issued vide letter no. EC/SEIAA/2014-15/352/2014/577, dated 20.11.2014 is being transferred to “**M/s Mahaveer Engicons Pvt. Ltd. 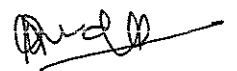

The above mentioned project proposal was considered in the light of section 11 of Environment Impact Assessment Notification, 2006 for transferability of Environmental Clearance. The SEAC considered the contents of letter dated 10.03.2025 from Kanhayia Kumar Singh addressed to Chief Secretary, Jharkhand and forwarded to Member Secretary, SEIAA by Joint secretary, Deptt. of Forest, Environment & Climate Change, Govt. of Jharkhand vide its letter no. 1460, dated 28.04.2025 and unanimously made its reply after due diligence and forwarded its report to SEIAA vide SEAC letter no. 20, dated 06.08.2025.

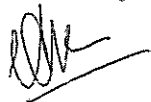
The SEIAA agreed with the detailed observation and findings of SEAC in this regard and unanimously decided to forward the report to the Joint secretary, Deptt. of Forest, Environment & Climate Change, Govt. of Jharkhand for onward necessary action.

II. **Monitoring of Six Monthly Compliance Report – Regarding.**

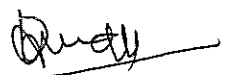
The SEIAA considered the mechanism of monitoring of Six Monthly Compliance Report submitted to Regulatory Authority in the light of EIA Notification, 2006, which is as follows:

Para 10 of EIA Notification, 2006

- i. (a) *In respect of Category 'A' projects, it shall be mandatory for the project proponent to make public the Environmental Clearance granted for their project along with Environmental Conditions and safeguards at their cost by prominently advertising it at least in two local newspapers of the district or State where the project is located and in addition, this shall also be displayed in the project proponent's website permanently.*
- (b) *In respect of Category 'B' projects, irrespective of its clearance by MoEF / SEIAA/DEIAA, the project proponent shall prominently advertise in the newspapers indicating that the project has been accorded environment clearance and the details of MoEF website where it is displayed.*
- (c) *The Ministry of Environment and Forests and the State / Union Territory Level Environmental Impact Assessment Authorities (SEIAAs)/ the District Level Environment Impact Assessment Authority (DEIAA), as the case may be, shall also place the environmental clearance in the public domain on Government portal.*
- (d) *The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt.*

- ii. *It shall be mandatory for the project management to submit half-yearly compliance reports in respect of the stipulated prior environmental clearance terms and conditions in soft copies to the regulatory authority concerned, on 1st June and 1st December of each calendar year.*
- iii. *All such compliance reports submitted by the project management shall be public documents. Copies of the same shall be given to any person on application to the concerned regulatory authority. The latest such compliance report shall also be displayed on the web site of the concerned regulatory authority.*

Para 1 of MoEF & CC O.M. No. J-11013/5/2009-IA.II, dated 29th June, 2010

"The Regional Offices of Ministry of Environment, Forest have been entrusted with the responsibility of monitoring of compliance status of the conditions stipulated while according Environmental Clearance to various developmental projects under the EIA and CRZ Notification. For the purpose, the Officers from the Regional Offices have been undertaking visits to the projects and based on the observation made during the visit, the monitoring reports are submitted to the Ministry of Environment and Forest. "

Ministry of Environment, Forest & Climate Change, Govt. of India issued Circular No. J-11013/6/2010-IA.II(Part), Dated 07.09.2017. regarding Environmental Clearance to the expansion projects/activities under the EIA Notification, 2006- Certified Compliance Report

"Para 3: Regional Offices of Ministry are requested to submit certified compliance report within one month of receipt of such request from Member Secretary of the Sectoral EAC. In case the inspection is not carried out within one month, the certified compliance report from the concerned Regional Offices of Central Pollution Control Board (CPCB) or the Member Secretaries of the respective State Pollution Control Boards shall also be accepted for deliberations by the Sectoral EAC."

Ministry of Environment, Forest & Climate Change, Govt. of India (Impact Assessment Division) vide letter no. J-11013/71/2016-IA(M), Dated 25.10.2017 addressed to all Principal Secretary of Environment Departments of all States Governments and Union Territory(UT) in which direction has been issued regarding compliance to the recommendation of CAG giving suggestions which inter-alia includes monitoring of EC conditions which are as follows:

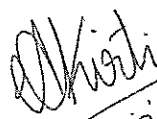
"2. (ii) To ensure monitoring of EC conditions through SPCB.

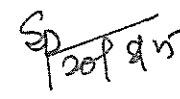
(iii) To strengthen the infrastructure and manpower of SPCBs so that EC condition of operational project can be monitored properly."

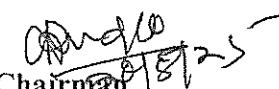
